These numbers are less than enrolments in 2017 when the total number of enrolments was 3310. There was a larger decrease in the number of part time students than full time – 2497 F/T and 813 P/T in 2017. There was an increase in the number of postgraduate students [275 in 2017] and a decrease in undergraduate numbers [3036 in 2017].

In 2017 Te Wananga o Aotearoa had the largest number of students enrolled 543. In 2018 their numbers dropped to 379. The largest provider is Massey University – 521 students in 2018, 536 in 2017.

Gender: Males 395 (13.9%); Females 2446 (86.1%). This is a slightly higher percentage of female students than in 2017 (84%)

In 2017 only 30% of students identified as Māori. We see a 18% increase in 2018. However, this increase is mainly made up by new entrants to the 4 year, undergraduate degree so 3 more years before the increased numbers reach the point of registration.

It should be noted that a number of students identify with more than one ethnicity

Students eligible to graduate:

At the end of 2018 there were 396 students eligible to graduate. This is substantially less than in 2017 when 691 students were eligible to graduate. However in 2017 a number of institutions graduated their final cohort of students from the three year degree and there was an increase in

numbers as students who may have been part-time or who had taken time off needed to complete in 2017 to meet the institutions regulations. In 2018 a number of institutions were still teaching in their 4 year degree so did not have a graduating cohort. This explains the low number of students in the year 4 of the undergraduate degree this year. In 2019 all institutions will have a full cohort of students in year 4 so the number of students eligible to graduate should rise again.

Placement information:

Programmes are required to provide students with 120 days of field education experience, with 100 days of this experience being in the last 2 years of the programme. There must be at least 2 different experiences and one must be at least 50 days. All institutions comply with these requirements. All programmes except 2 do 2x 60 day placements. The remaining two do 30/90 and 50/70. In total there were 971 placements throughout 2018 [1272 in 2017].

27 students did not complete placements for reasons other than a fail grade – reasons included personal and family reasons, no longer e met fit and proper requirements health issues, complaint against student, student withdrawn from degree)

20 students received a fail grade.
